This includes outlining the pros and cons of disclosure, framing disclosure as an ongoing process, describing a developmental appropriate approach to disclosure, outlining family responses and expectations around disclosure, listing obstacles to disclosure and sharing Tygerberg approaches to answering a child's questions about the illness in an age appropriate manner.
